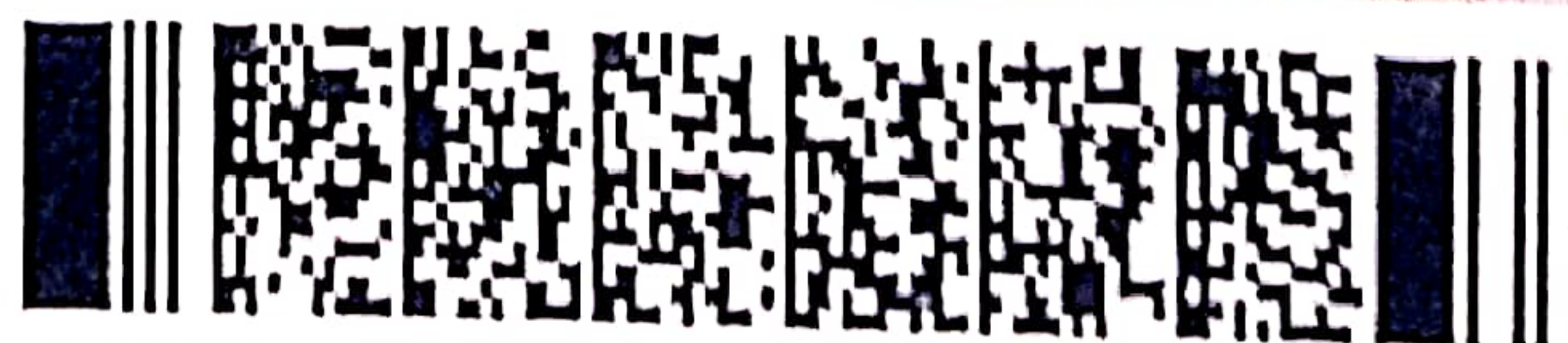



In our opinion and proper books of account have been kept by the above named Society so far as appears from our examination of the books.

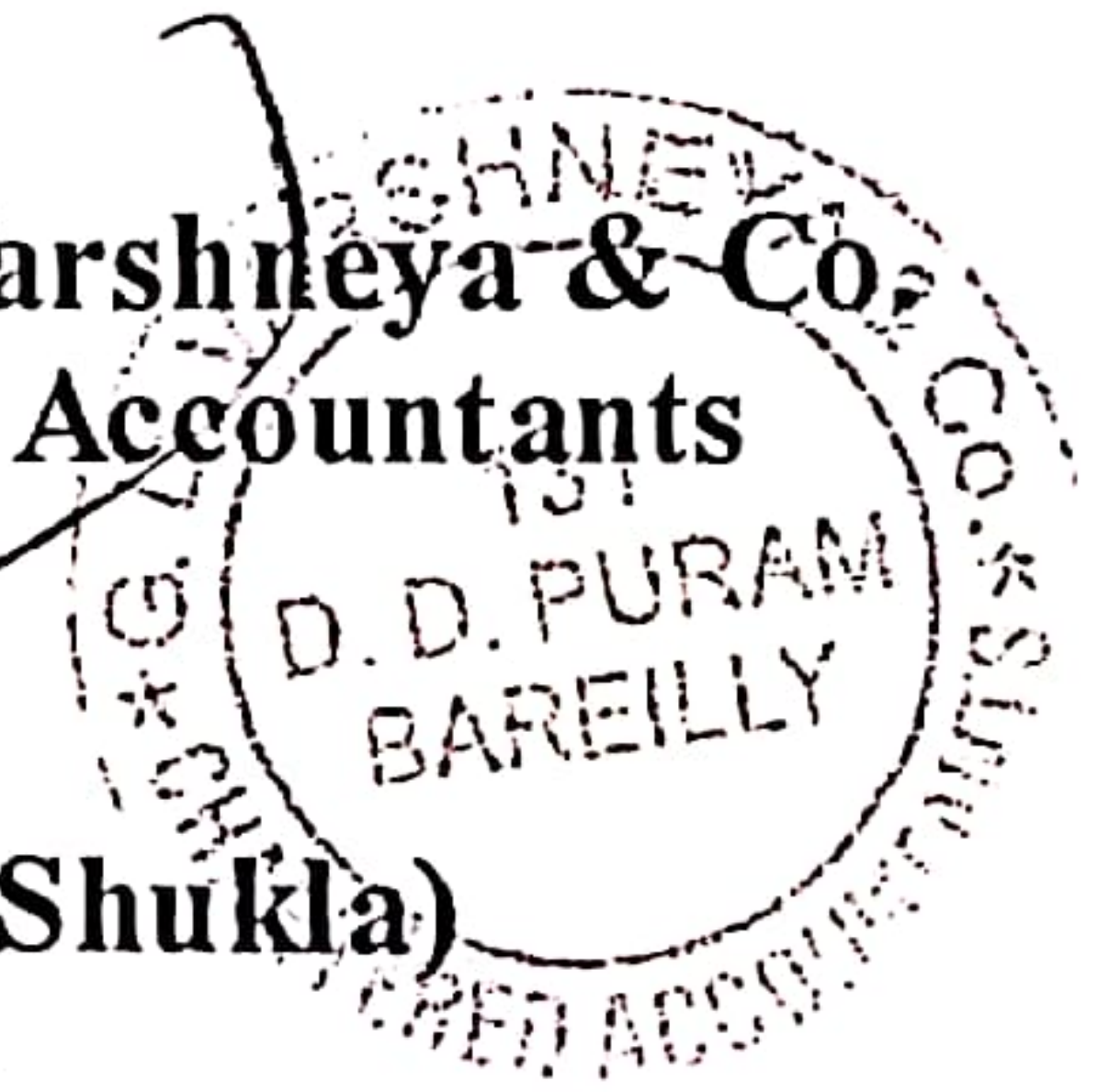




